## Gage County Board Minutes

The Gage County Board of Supervisors met on May 17, 2023, at 8:46 a.m. with Terry Jurgens, Emily Haxby, Don Schuller, Erich Tiemann, Eddie Dorn, Dave Swavely and Gary Lytle present.

Notice of said meeting was posted at the County Clerk's Office and published prior to the meeting in compliance with State Statutes.

Let the record show that all proceedings are electronically recorded.

Chairman Tiemann announced that a complete copy of the Open Meetings Act is posted at the back of the Board of Supervisors Room.

Consent Agenda included the following items: 1. General Agenda; 2. Minutes from previous meeting and committee meetings; 3. claims audit in the amount of \$1,460,947.12; 4. approve correspondence received and place on file; 5. Approve receiving Sheriff's Statement on collection of distress warrants for April, 2023; 6. Utility Permit #1272 to Windstream Nebraska LLC. - Windstream will be installing a communications line to residence at 28045 South 80<sup>th</sup> Road. Windstream will bore a 2" diameter by 60" deep line for the new line from pedestal 160XD located in the Northeast grader ditch of South 80<sup>th</sup> and Belvidere, bore under 80th Road to West grader ditch and then bore under Belvidere Road to South grader ditch, then continue all work on private property. Located in the southwest corner of Section 2, Southeast corner of Section 3, and Northeast corner of Section 10, T-3-N, R-7-E, Rockford Twp.; 7. Items of discussion were desks in Dist. Court; putting flags around courthouse on May 24 – May 30; valuation protest process; BASWA, roads, hours, recycling options; dust control for roads.

Motion made by Jurgens, seconded by Lytle to approve recommendation to NE Liquor Commission on Special Designated Liquor License for Bottle Rocket Brewing, LLC for an event to be held at The Barn Event Center, 2331 W Ash Rd., Cortland NE, on June 10, 2023. Motion carried 7-0.

Motion made by Lytle, seconded by Dorn to approve Community Based Juvenile Services Aid Grant and authorize Board Chairman to sign the Grant Award. Motion carried 7-0.

Discussion on State Line Bridge adjacent to Lineweber property. Tiemann said he's spoken with Marshall County. County Attorney Roger Harris suggested the board go into closed session if they are going to discuss options.

Motion made by Dorn, seconded by Schuller to move into closed session at 9:33 a.m. for possible negotiations and security. Motion carried 7-0.

Jurgens and Lytle left meeting at 9:58 a.m. during closed session.

Lytle back in meeting at 10:09 a.m.

Motion made by Dorn, seconded by Swavely to move out of closed session at 10:10 a.m. Motion carried 5-1 with Lytle voting nay.

Schuller said he attended the Liberty Board meeting and said he was very impressed with the area and improvement grants for water facility.

Tiemann stated that Marcella Rademacher would like to formally request that the board to review the CAFO requirements.

Motion made by Dorn, seconded by Swavely to adjourn the Board of Supervisors meeting at 10:18 a.m. Motion carried 5-1 with Lytle voting nay.

Chairman declared Board of Supervisors meeting adjourned at 10:18 a.m. until May 31, 2023.
