

The Gage County Board of Supervisors met on July 12, 2023, at 8:45 a.m. with Terry Jurgens, Emily Haxby, Don Schuller, Erich Tiemann, Eddie Dorn, Dave Swavely and Gary Lytle present.

Motion made by Swavely, seconded by Lytle to approve the consent agenda. Motion carried 7-0.

Motion made by Dorn, seconded by Swavely to approve claim #23070050 to Johnny's Welding in the amount of \$135.52. Motion carried 6-0-1 with Jurgens abstaining due to conflict of interest.

Motion made by Swavely, seconded by Dorn to approve claim #23070057 to R.L. Tiemann Const. Inc. in the amount of \$45,026.82, bringing the total amount of claims paid through July 12, 2023 to \$693,706.47. Motion carried 6-0-1 with Tiemann abstaining due to conflict of interest.

No public present for comments or request for future agenda items.

Committee reports were given by Dave Jones on Bldg. & Grounds, Tiemann on Equalization, Jurgens on Finance/Insurance, Scott Bates on Veteran's Service, and Haxby on Road & Bridge. Items of discussion included security updates, removal of pole in center of board room, update to audio equipment in courts next week, valuation protests, mental health care available for veterans, and the grant process for roads & bridges.

Matt Kasik, Chief Executive Officer at Region V Services, appeared before the board with Chelsea Meints, Director of the Beatrice program in Gage County, and Michele Scholz, the Chief of Staff. Kasik presented their Annual Report and talked to the board about their services for those with developmental disabilities. He said that Region V is one of the original six regions set up in the late 60's, early 70's by the State Legislature, and is the largest provider for

developmental disabilities support in the State of Nebraska. Gage County Region V serves about 50 people and is growing rapidly, owns 6 group homes, and has about 64 employees. Kasik said they focus on employment of the individuals they serve and he provided a list of employers to recognize and thank them.

Motion made by Lytle, seconded by Swavely to receive the Region V Annual Report and place it on file. Motion carried 7-0.

Motion made by Jurgens, seconded by Lytle to approve a 1% increase for the lid on restricted funds. Motion carried 7-0.

Motion made by Haxby, seconded by Lytle to approve recommendation for two Special Designated liquor licenses for Gage County Ag Society, one for Gage County Fairgrounds beer garden on the Midway for the Gage County Fair, July 26-29, 2023, and one for the Bull Riding Rodeo at the Horse Arena, July 26, 2023. Don Esau from the Ag Society was present, inviting the board to come out to the fair, and handing out flyers for the Gage County Fair. Motion carried 7-0.

Discussion on a request for a Detention Center needs assessment was led by Lytle, saying the Sheriff would like to request that the board look at what is needed at the jail overall to address adequate jail services, for both the staff and inmates.

Motion made by Haxby, seconded by Dorn to approve a Detention Center needs assessment. Motion carried 7-0.

Chairman declared Board of Supervisors meeting adjourned at 9:21 a.m. until July 26, 2023.
