The Gage County Board of Supervisors met on September 20, 2023, at 8:45 a.m. with Terry Jurgens, Don Schuller, Erich Tiemann, Eddie Dorn, Dave Swavely and Gary Lytle present, Emily Haxby absent.

Notice of said meeting was posted at the County Clerk's Office and published prior to the meeting in compliance with State Statutes.

Chairman Tiemann announced that a complete copy of the Open Meetings Act is posted at the back of the Board of Supervisors Room.

Motion made by Swavely, seconded by Schuller to approve the consent agenda. Motion carried 6-0.

Motion made by Jurgens, seconded by Dorn to approve claim #23090247 to Hard Rock Quarries, LLC in the amount of \$3,109.36 and claim #23090256 to R.L. Tiemann, Inc. in the amount of \$151,536.61, bringing the total amount of claims paid through September 20, 2023 to \$707,395.55. Motion carried 5-0-1 with Tiemann abstaining due to conflict of interest.

Ralph Bodie, 70688 606<sup>th</sup> Ave., Liberty NE, spoke to the board during public comments. He said he's lived through the Cuban Missile Crisis and watched 50,000 men die in Vietnam serving in the military, all due to communism, and what's happening now in Ukraine with Russia, it's all from communism. And now we're inviting communists to raise hogs in America? He sold his hogs 3 years ago and only got 15% of what the value should have been. He said these hog operations destroy the water table with antibiotics and nitrogen gets in the water table. He is not against free enterprise but he is against communism. He tried to contact the Governor and the Lt. Governor and neither were accessible or take responsibility for what's happening. He said the board has a responsibility to the citizens of Gage County, to veterans, and to the flag and the republic for which it stands. The flag means something to him because he served his time in the military and served it well. He wants the board to have the knowledge needed to refuse these operations in Gage County.

Clint Ruyle, 60619 710<sup>th</sup> Rd., Liberty NE, spoke under public comments. He wanted to remind everyone that on June 28<sup>th</sup> the road where the CAFO is proposed was considered unsafe but the CAFO wasn't concerned about safety until we held their feet to the fire and made them come up with a route. He's concerned that it will be the same when they go to apply manure, and where they apply it, and the available acres, and that they're not going to comply until we hold their feet to the fire again. He has had several family members serve in the military and is concerned about what it says to our veterans when we give away our quality of life and what they fought for to a foreign entity. Quality of life means a lot to them in their community. A hog operation used a manure injector like the ones Summit is using to inject manure in a field five miles away from his residence and they could smell it – it's going to stink! He said his dad and son both served in the military and he has a grandson who just graduated from Air Force boot camp who wants to serve, and he feels we need to respect our veterans and not give away the quality of life they fought for to a foreign entity.

Committee reports were given by Dave Jones on Bldg. & Grounds/Winter Lights, Tiemann on Equalization, Jurgens on Finance/Insurance, Shf. Gustafson on Law Enforcement, Lisa Wiegand on Emergency Management and P&Z, and Jurgens on Road & Bridge. Topics of discussion included continuing masonry work on courthouse exterior; property valuations; placement of acoustic panels; re-seeding parking areas; P&Z meeting Sept. 26<sup>th</sup> at 6:30 p.m.; Shf. officers training; and update on seized horses.

Motion made by Lytle, seconded by Swavely to approve Gage County Tourism Agreement between County of Gage and Beatrice Area Chamber of Commerce for 2 years, effective July 1, 2023 through June 30, 2025. Motion carried 6-0.

Motion made by Jurgens, seconded by Swavely to approve agreement between Gage County and the State of Nebraska, Dept. of Transportation on a Statewide Upgrading of Existing Stop Sign Locations of Rural Roads. The state is funding a program to replace rural stop signs with new signs and posts with reflective tape, and the Hwy Dept. will provide the labor to replace them. Motion carried 6-0.
