## RESOLUTION & STATEMENT OF FACTS

WHEREAS, the Gage County Board of Supervisors has been presented with a request for a special use permit, (SUP) #2024-3 for the placement of a Commercial Retail Business;

WHEREAS, the Gage County Planning Commission ("Planning Commission") and Gage County Board of Supervisors ("Board") are duly authorized under the Gage County Zoning Regulations and are required to adopt a Statement of Factual Findings according to Neb. Rev. Stat. § 23-114.01(6) (Reissue 2012);

WHEREAS, the Planning Commission and County Board have established the following Statement of Factual Findings:

- 1. An application was submitted for a Special Use Permit ("SUP") for a Commercial Retail Business located in an agricultural zoning district on a tract of land in the NE ¼ of NW ¼ of Section 33-3-5 in Lincoln Township, Gage County, Nebraska.
- 2. On June 18, 2024, the Planning Commission held public hearings to receive input on SUP #2024-3. The opportunity for public comments was held for testimony in support of, neutral to, and/or in opposition to the SUP.
- 3. On June 18, 2024, the Planning Commission voted 5-0 to recommend approval of the SUP #2024-3 finding that the location and land use is suitable to operate a commercial retail business.
- 4. In recommending approval of SUP #2024-3, the Planning Commission found that the Application complied with the guidelines of Article 6.2 of the Gage County Zoning Regulations.
- 5. On July 10, 2024, after proper notice and publication, the Board held a public hearing and public comments were heard in support of, neutral to, and/or in opposition to the SUP #2024-3.
- 6. On July 24, 2024, the Board considered whether the Application met all the requirements of the Gage County Zoning Regulations and held a vote to approve or disapprove SUP #2024-3.
