Motion by Dorn, seconded by Adams to approve all Rock and Gravel bids that were received at the February 19th meeting, utilizing each according to lowest price and availability. Motion carried 4-0.

Motion by Lytle, seconded by Adams to approve Needs Assessment for Detention Center from Prochaska & Associates. Motion carried 4-0.

Motion by Lytle, seconded by Adams to approve Keil Mick as the Gage County Veteran's Service Officer. Motion carried 4-0.

Motion by Adams, seconded by Lytle to approve service agreement between Maximus US Services and Gage County for services for Cost Allocation Plan ending December 31, 2029. Motion carried 4-0.

Motion by Dorn, seconded by Lytle to approve closing bids at 9:15 a.m. and accept, reject or award bids for Filley Southwest Overlay Project C-34(1181), Rockford blacktop. Motion carried 4-0.

Bids were received from Pavers, Inc. of Waverly, NE in the amount of \$564,926.89; Constructors, Inc. of Lincoln, NE in the amount of \$555,364.83; and Cather & Sons Construction of Lincoln, NE in the amount of \$547,379.08. Bids were referred to Hwy Dept. for inspection and recommendation later in the meeting.

Motion by Adams, seconded by Dorn to approve RFQ (Request for Qualifications) for Engineering Services of CPF Grant. Motion carried 4-0.

No action taken on agenda item to approve or disapprove a request for consultant proposals (RFP) for the purpose of engaging in the design, siting and construction administrative services for a proposed Multi-Custody Correctional Facility. This will be on the March 19, 2025 agenda.

Hwy Supt. Kuhnke recommended accepting the lowest bid from Cather & Sons for the Filley SW Overlay Project in the amount of \$547,379.08, with a projected completion date of June 1, 2025, to mill off 2", repair, and put back 2".
