## Gage County Board Minutes

The Gage County Board of Supervisors met on March 19, 2025, at 8:48 a.m. as per public notice given on the county website and in the Beatrice Daily Sun on March 6, 2025, copy of the proof of publication being on file in the County Clerk's Office. The agenda for all meetings is kept continually current and is available for public inspection at the County Clerk's Office during normal business hours and was communicated in the advance notice of the meeting. The Board of Supervisors has the right to modify the agenda to include items of an emergency nature only, at such public meeting. All of the proceedings shown hereafter were taken while in the convened meeting which was open to the attendance of the public.

Supervisors Rex Adams, Rick Clabaugh, Emily Haxby, Erich Tiemann, Gary Lytle and Eddie Dorn present, Terry Jurgens absent.

Chairman Tiemann announced that a complete copy of the Open Meetings Act is posted at the back of the Board of Supervisors Room.

Motion by Adams, seconded by Clabaugh to approve claim #25030203 to R.L. Tiemann Const. Inc. in the amount of \$25,485.09, bringing the total amount of claims approved through March 19, 2025 to \$708,378.94. Motion carried 5-0-1 with Tiemann abstaining due to conflict of interest.

No public present for comments or request for future agenda items.

Committee reports were given by Dave Jones on Building & Grounds; Tiemann on Equalization; Lisa Wiegand on Emer. Mgmt. & Dorn on Road & Bridge. Topics included electrical outage, and sewer line damaged at Extension office.

Rachel Kreikemeier, NGage Executive Director, presented their Quarterly report.

Motion by Lytle, seconded by Dorn to receive and place the NGage report on file. Motion carried 6-0.

Dakota Hurley, Tourism Coordinator, and Shirley Martin presented the Visitors Improvement Grant for One Property at a Time for Blue Springs Tourism Enhancement Project in the amount of \$7,000.00.

Motion by Lytle, seconded by Dorn to approve Visitor Improvement Grant for One Property at a Time in the amount of \$7,000.00. Motion carried 5-0-1 with Adams abstaining due to conflict of interest.

Monte Murkle was present and spoke about World Down Syndrome Day, which is March 21, 2025.

Discussion on the request for consultant proposals (RFP) for the purpose of engaging in the design, siting and construction administrative services for a proposed Multi-Custody County Jail.

Motion by Lytle, seconded by Dorn to approve RFP for the purpose of a Multi-Custody County Jail, due April 16, 2025 at 9:15 a.m. Motion carried 6-0.

Motion by Lytle, seconded by Haxby to approve recommendation on Special Designated Liquor License for Red Barn Farm for St. Paul's Evangelical Lutheran Congregation wine/ale/spirit tasting fundraiser on April 25, 2025. Motion carried 6-0.

Discussion took place on agreement with City of Beatrice for Emergency Dispatch Services.

Motion by Dorn, seconded by Haxby to approve giving the City of Beatrice notice on the Emergency Dispatch Services contract in order to begin discussions. Motion carried 6-0.

Discussion took place on ending or increasing roadside shredding.

Motion by Adams, seconded by Haxby to approve ending road side shredding of any vegetation by the county forces other than around county structures. Motion carried 5-1 with Dorn voting nay.

Motion by Haxby, seconded by Clabaugh to approve removing C-34 (1262) (Clatonia box culvert) from the contract with Vogtscapes. Motion carried 6-0.

Chairman declared Board of Supervisors meeting adjourned at 10:22 a.m. until April 2, 2025.
