

The Gage County Board of Supervisors met on January 7, 2026, at 8:45 a.m. as per public notice given on the county website and in the Beatrice Daily Sun on December 11, 2025, copy of the proof of publication being on file in the County Clerk's Office. The agenda for all meetings is kept continually current and is available for public inspection at the County Clerk's Office during normal business hours and was communicated in the advance notice of the meeting. The Board of Supervisors has the right to modify the agenda to include items of an emergency nature only, at such public meeting. All of the proceedings shown hereafter were taken while in the convened meeting which was open to the attendance of the public.

Supervisors Rex Adams, Rick Clabaugh, Emily Haxby, Erich Tiemann, Gary Lytle, Eddie Dorn, and Terry Jurgens present.

Let the record show that all proceedings are electronically recorded.

Pledge of Allegiance recited.

Chairman Tiemann announced that a complete copy of the Open Meetings Act is posted at the back of the Board of Supervisors Room.

There was no old business so Chairman Tiemann declared 2025 session formally closed – SINE DIE.

County Clerk Dawn Hill assumed the meeting and called for nominations for Board Chairperson. Gary Lytle nominated Erich Tiemann for Chairman. Terry Jurgens nominated Emily Haxby for Vice Chairman and made a motion to cease nominations and cast a unanimous ballot for Erich Tiemann as Chairman and Emily Haxby as Vice Chair. Motion Carried 7-0.

Hill turned the meeting back over to Chairman Tiemann.

Motion made by Dorn, seconded by Jurgens to approve the consent agenda. Motion carried 7-0.

Motion made by Dorn, seconded by Lytle to approve claim# 2601000042 to Johnny's Welding in the amount of \$241.24. This brings the total amount of claims paid through January 7, 2026, to \$568,464.04. Motion carried 6-0-1 with Jurgens abstaining due to conflict of interest.

No public present for comments or request for future agenda items.

Committee reports were given by Dorn & Dave Jones on Bldg & Grds, Tiemann on Equalization & Human Resources, Jurgens on Finance, Keil Mick on Veterans Service, Lytle & Lisa Wiegand on Law Enf & Emg Mgmt & Haxby & Mark on Rd & Bridge. Items of discussion included winter lights off of the trees; date of National Weather Service on 2/26 at Homestead Monument; P&Z Mtg on 1/22.

Motion by Adams, seconded by Lytle to approve appointing Amanda Fanning as Gage County Attorney due to Roger Harris's retirement. Motion carried 7-0.

Discussion took place on the Visitor Improvement Grant dollars available per grant. Haxby suggested a tiered process.

Motion by Haxby, seconded by Lytle to approve Visitor Improvement Grants based on percentages. For grants that have a project total of up to \$50,000 they could receive up to 50% in grant dollars with a \$25,000 max and would have a (1) one-year waiting period before applying again. For grants that have a project total of up to \$150,000 could receive up to 35% in grant dollars with a \$52,500 max and would have a (2) two-year waiting period before applying again. For grants that have a project total over \$150,000 could receive up to 20% in grant dollars with a \$75,000 max and would have a (3) three-year waiting period before applying again. Motion carried 7-0.

Motion by Haxby, seconded by Lytle to approve Visitors Improvement Grant to Beatrice Youth Recreation, Inc. in the amount of \$50,000 for Hannibal Park Ballfield Initiative. Motion carried 7-0.

Break at 9:32 a.m. Back in session at 9:42 a.m with Tiemann and Jurgens out of meeting.

Discussion took place on Professional Services relating to Residential and Commercial Property Configuration. Present and speaking with the board was Derek Neiderklein with MIPS.

Chairman declared Board of Supervisors meeting adjourned at 9:52 a.m. until January 21, 2026.
